# What is this document and why should you read it?

### Who do we share this data with?

We do not share the personal data you enter into the Specification Hub with anyone. It is solely used by Busy Bees for managing the Specification Hub website and for operational communications.

Your data is kept in password-protected, limited access files within Busy Bees.

Our website is hosted by our outsourced service provider in the United Kingdom and is subject to UK GDPR under supervision of the Information Commissioners Office (ICO)

#### How do we keep your data safe?

At Busy Bees we employ physical, electronic and managerial control procedures to safeguard and prevent unauthorised access, accidental loss, destruction or damage of your personal data. Our outsourced service providers who support our operations are also vetted to ensure that they have appropriate technical and organisational measures in place to protect your personal data. Your personal data will be carefully stored, password protected and accessible by a limited number of named individuals.

### Cookies

Similar to other commercial websites, Specification Hub uses technology called "cookies". We only use essential cookies which ensure the site runs efficiently.

Optional videos added to the Specification Hub may, use different cookies such as Wistia. You can manage these cookies via your computer settings.
